 two parties it was agreed that the Joint Local Plan would be split into 2 parts.
 This is to allow for part 1 to move forward while work is carried out on part 2.
 There is still no confirmation of timing for the process to be completed.
- The details of the taxbase numbers have been sent to all parishes. The
 taxbase is the amount of equivalent Band D homes that council tax will be
 paid on. This is not an exact number as it includes the calculation for those
 that receive subsidies or reliefs. Haughley's is £604.83 which is an increase on
 the current year.

They have confirmed that although they do not anticipate any significant changes, they will confirm the Final Tax Base early January 2022. The three highlighted routes were: Green Road, The Green, Old Street and Fishponds Way Station Road, Windgap Lane with St Mary's Avenue Haughley Green G Brown reported that the Gallowsfield Wood held a working party at the Wood on Saturday 11th December, a temporary closure order on Footpath 1 at the level crossing a short distance south of Wetherden Road and he is awaiting communication with Suffolk Fire and Rescue Service re the safe siting of a proposed beacon. 24.
